


AGAINST ABUSES AND HUMAN TRAFFICKING

About the project

Annually, in March, TEAW (Together Empowering all Women) gathers more than 100 law students from all over the world in a volunteer awareness action. Usually, in each partner University/NGO, there is a group of students raising awareness on specific women's rights for the celebration of the International Women's Day and awareness on THB for the Freedom Day (14th of March). During the 3rd week of March, the participants meet in an online conference, presenting the activities that they have implemented. In the meantime, they cooperate online to exchange ideas and good practices. It is a international cooperation, with multicultural aspects, that has been highly appreciated by the students involved.

/04 Empower Vulnerable Populations





Moreover, we also had a group discussion on the topic Cyber Violence against women. Also our students from NLU Sonipat conducted a poster making competition to raise awareness, also some of our students from Ambedkar Law University Tamilnadu also conducted a Breaking stereotype campaign.

In a proactive move towards fostering awareness and action against human trafficking and gender-based violence (GBV), **Cavendish University Uganda's Law Clinic** spearheaded a campaign, leveraging various platforms to advocate for justice and societal change, through a series of initiatives ranging from panel discussions to street law campaigns, and shooting a campaign video the university community united in solidarity to combat these pervasive issues. The university led a comprehensive campaign against human trafficking and gender-based violence (GBV). They utilized posters, panel discussions, movie nights, and street law campaigns to raise awareness and spark action.



These efforts aimed to educate and empower the community and the public to prevent these injustices. Through dialogue, education, and grassroots engagement, the campaign fostered a collective commitment to advocating for justice and promoting human rights.

Cavendish University Uganda's Law Clinic learned the importance of approaches in addressing complex social issues like human trafficking and GBV. They found that raising awareness through various ways was key to engaging diverse audiences and fostering a sense of collective responsibility.

We presented inspiring and famouswomen from the STEM industry and the history of our country, as well as the organizations that women take part on a daily basis to shape a better community for everyone. Moreover, we organized a session of discussions with students about the role of women in creating our world and held a quiz about some general knowledge about women in our society."

For the successful running of the TEAW project in Romania, the students of the Center for Human Rights and Migration from the Romanian-American University have organized activities to promote the rights of women and to raise awareness on the main risks of human trafficking. In the first week of March, RAU students organised group discussions, online campaigns and on-spot meetings with about 1000 high school students, professors, and parents.





Since the 1st of March, the month dedicated to women, the Center opened an event on the Facebook page, where were posted messages on women's rights and cyber violence, a phenomenon increasingly present in everyday life, wanting to reveal the virulence of this form of violence, its effects and target audience.




